

Not All Boating Accidents Happen On The Water

When it comes to trailered boats nine out of ten trailering malfunctions and accidents can be directly traced back to a failure to dedicate some time to the most basic preventative maintenance. Wheel bearings, suspension parts, lights, and a host of other components require constant attention to help insure any trailering trip smooth and hassle free. Special attention to the tow vehicle's hitch is a good idea, as that is the only link between the tow vehicle and trailer.

Also consider the fact that one needs a special license and classification to drive things like motorcycles, school busses and vehicles with air brakes like semi-trailer trucks, gravel trucks, etc. But just about anyone can go out and buy a \$30,000 boat and trailer, attach it to his/her car and simply drive away. No special training is required beforehand and no special license classification is needed.

Anyone who has ever hauled a boat around for a number of years knows that it may not be too difficult to drive in a straight line at low speeds. But when it comes to things like driving at highway speeds, passing other vehicles, high winds, backing up, etc... the task becomes much more difficult than one might think.

Pete's amazing adventure

The following story is pretty amazing if not quite an adventure. On Sunday afternoon, November 21 I was at my desk checking email when the phone rang. The caller was in Australia and inquired if I would survey a boat in Lexington County and assist him in the purchase assuming the boat checked out. Skeptical? You bet, but curious too so I decided to keep the conversation open. The boat is a Moomba and is a wake setter type, the seller a Clemson student taking exams and the buyer is a plumber in Queensland, Australia.

A lot of email and phone communication followed: buyer and seller, myself with both the buyer and the seller and including correspondence with a surveyor I know in Australia whose home is only three miles from the plumber. The plan at 3 PM on Tuesday, November 23 was; The seller would transfer funds to an account of mine (I had evacuated and isolated the account to receive deposits only), If the survey, scheduled for 11 30 AM on Wednesday the 24th



was ok I was to buy the boat, bring it to the upstate and hold it until shipping arrangements were made by the buyer.



That is exactly what happened. On Wednesday at 8 AM a wire transfer for \$2x,xxx appeared in my account. By 9 AM the bank had prepared a cashier's check in the amount of the purchase price and I started my drive to Gilbert, SC. At 11 30 the survey went well and by 1 PM I was on my way home with title and boat. Can you imagine?

I mean imagine the power of the internet. The Australian found the boat on the internet, and then he found me, a member of the surveyor's society who was able to assist him. Next, the criteria for the inspection and purchase were set up. Funds

were wire transferred, the boat was inspected, bought and is in storage awaiting transport, all in the space of 72 hours. Such intercontinental communication and commerce is common to my grandchildren, comfortable for my children and pretty much impossible magic for my parent's generation. And for me, it is amazing.

Boating Accident Death Statistics Show Slight Improvement Accident and Injury Rate Up Slightly



Collisions accompanied by drowning are chief causes of boating fatalities.

In June, the Coast Guard published *Recreational Boating Statistics 2019*, the 61st annual report, with statistics on recreational boating accidents and state vessel registration. This publication is a result of the coordinated effort of the Coast Guard and those states and territories that have Federally-approved boat numbering and casualty reporting systems. These include all states, the District of Columbia, Puerto Rico, Guam, the Virgin Islands, American Samoa, and the Commonwealth of the Northern Mariana Islands. Here are some highlights from the report.

National Incident Numbers

In 2019, the Coast Guard counted 4,168 accidents that involved 613 deaths, 2,559 injuries and approximately \$55 million dollars of damage to property as a result of recreational boating accidents. Compared to 2018:

The number of accidents increased 0.6%.

The number of deaths decreased 3.2%

The number of injuries increased 1.9%.

The number of boat registrations nationally remained essentially unchanged.

National Incident Rates

The fatality rate was 5.2 deaths per 100,000 registered recreational vessels. This rate represents a 1.9% decrease from the 2018 fatality rate of 5.3 deaths per 100,000 registered recreational vessels.

Drowning Without PFDs A Leading Cause of Fatalities

Where cause of death was known, 79% of fatal boating accident victims drowned. Of those drowning victims with reported life jacket usage, 86% were not wearing a life jacket.

Alcohol Use Remains The Leading Contributing Factor In Boating Deaths

Where the primary cause of fatalities was known, alcohol use was listed as the leading factor in 23% of deaths.

Other factors in the top five:

Operator inattention

Improper lookout

Operator inexperience

Excessive speed

The Critical Role of Boating Safety Instruction

Where instruction was known among victims, 70% of deaths occurred on boats where the operator did not receive boating safety instruction. Only 20% percent of deaths occurred on vessels where the operator had received a nationally-approved boating safety education certificate.

Types of Boats Involved In Incidents



Cabin motorboats are surprisingly almost as often involved in accidents as are personal watercraft. The most common vessel types involved in reported accidents were:

Open motorboats (45%)

Personal watercraft (19%)

Cabin motorboats (16%)

The vessel types with the highest percentage of deaths were:

Open motorboats (48%)

Kayaks (14%)

Personal watercraft (8%)

South Carolina



Groundings are the third most common category of boating accidents in South Carolina.

In South Carolina last year, there were 141 reported accidents resulting in 15 deaths; 11 by drowning.

The leading cause of accidents was collisions between boats (41). Other leading causes were:

Collisions with objects (26)

Grounding (14)

Falls overboard (9)

What Can We Do To Promote Safe Boating?

In our education and civic service efforts, can LHBC have an effect in our corner of the state? Assuming we follow national trends, we can make an impact with our ABC *IF* we can get the students to sign up. In the ABC course, we address some of the leading causes of accidents and deaths by:

Promoting PFD use

Warning about skippering a boat while impaired

Training in following COLREGS (rules of the road)

Keeping lookouts

Teaching about the skipper's legal responsibilities

Additionally, our Vessel Safety Check services can promote safety education and engage skippers in addressing shortcomings in many areas of boat operation.

Plans for our Fall Conference and Change of Watch have changed.

Please read information sheet from Commander Jim Wilkins.

Due to the threat of the coronavirus, the D26 Fall Conference & Change of Watch will not be conducted at a central location. Instead, it will remotely be conducted by a series of teleconferences to include some or all of the following topics:

- Seminars/Workshops as recommended by the Conference Planning Committee...perhaps topics like SARS, Merit Marks, etc
- An awards teleconference to recognize member and Squadron recipients of 2019 awards. Where possible, pictures of the recipients will be displayed with each announcement
- Subsequently, the awards and recipients will be identified in the next O26 True
- Council/Conference teleconference to complete necessary business, such as approval of 2021 Budget, election of officers, etc
- Change of Watch teleconference, officiated by C/C Mary Paige, to accomplish the installation of the 2021 Bridge officers
- Other teleconference(s) as deemed appropriate

A registration form will be developed to allow members to indicate the teleconferences he or she intends to participate in...this will allow teleconference moderators to know the number of people participating. The teleconferences would be staggered over a two day period of October 30 & 31.

The D26 Conference Planning Committee will assist in defining the teleconferences to be conducted and in defining the media (FreeConferenceCall, Zoom, etc.) best suited for supporting the event.

The D26 Bridge, with assistance from District members, will have responsibility for the accomplishment of this teleconference • Embassy Suites has agreed to a physical postponement of the use of their facilities from October of this year to October of 2021 without penalty. To accommodate this change, the Lake Hartwell Sail & Power Squadron and the Golden Corner Lakes Sail & Power Squadron have agreed to postpone their hosting of the Fall Conference/COW from 2021 to 2022. Hosting of the October, 2021 Conference/COW has yet to be defined between Dreher Shoals Sail & Power Squadron and Lake Murray Power Squadron.The D26 Conference Planning Committee will revisit the C&R and Conference Rotations to determine if some modifications will be in order.


They are again planning the haunted house at the old dam. Here is a link to last year's event. https://6fearsdam.com/
