April brings two boating events. The first is the "Shakedown" cruise. This is an opportunity to get your boat ready for the summer, receive a VSC (vessel safety check) inspection, and a sticker if you pass. The specific date will be set as we get closer to April so that we can monitor the weather and pick a Saturday morning with good weather. That means you have 44 days (from the date of this writing: January 15) to get ready to launch as early as April Fools Day. Note: as of this writing, the date is set for April 17th.

Next, on April 21-25, the District Cruise and Rendezvous will see the Beaufort and Hilton Head squadrons collaborate to give guided tours of the waterways in their area. This fantastic opportunity will be culminated with a Blue Angels flight demonstration. After your vessel is tuned up by the "Shakedown" you will be ready to explore the nooks and crannies of the Carolina coast. If trailering to the coast is not your cup of tea, plan on bumming a ride with the locals. While specific details of each day are still in the planning stage you can make hotel reservations now and start coordinating your travel plans to the coast. Of course, you can monitor the websites for the District, Beaufort and Hilton Head squadrons to stay abreast of forming itineraries.





Things you see as a marine surveyor. A story.

Principal character: Retired Navy Veteran on 100 % disability. Annual income \$60,000. Other characters: residents on the same dock, active in rescue and guidance. A surveyor. A marina man-

ager.



Boat #1 Sank in slip on or about Christmas Day.. Not insured, cost estimate to raise, dispose of, repair dock \$50,000. The boat sank after a strong storm with significan't waves filled the bilges and the bilge pumps failed to evacuate. The veteran was discovered in a diabetic coma aboard the sinking vessel by nearby dock residents.

Boat # 2 Older Carlcraft houseboat in nearby slip. The veteran is living in and renting the Carlcraft along with his two dogs. The owner has offered to sell the vessel to the veteran at \$18,000 and he commissioned an "in water" prepurchase survey (no haul out, no trial run). The obiective of the survey was to receive a "fit for intended use a residence on the lake" report. The owner was not on site. No ships papers (registration/documentation) are on board. The marina manager reports this vessel is insured.

Decking, cleats and bow roof present numerous FRP patches. Two roof top air conditioners present broken covers and are not functional. Both bilges, bow and machinery space, present water, perhaps 8 to 12 inches with oily film and debris. Neither space was entered. A wooden starboard stringer with a starboard engine's outboard engine mount has advanced dry rot and pieces are falling off. Batteries are unsecured and uncovered, both in the engine space and in the lower portions of the forward cabin. 12 volt system is not operable. At the time of the inspection there was no 12 volt power. The alternating current system is not functional, more than half of the outlets are unpowered. Those outlets with power throw the breaker at the shore power pedestal if more than one or two appliances are powered up. Obviously only a few appliances can be operated at a time. Inconvenient when electric power is the single energy source. There are two electrically operated heads on the vessel. The aft unit is functional. The forward unit is inoperable and is fouled.

No additional inspection activity was necessary nor was it possible without power. The vessels value as it sits is zero. Ball park estimates of repair to make the vessel inhabitable exceed the asking price of the vessel. The survey was terminated.



The Underappreciated Safety Risks Of Bowrider Boat Designs



Bowriders, or boat types with open bows, are quite popular and marketable, especially to young families. The category includes modified runabouts, deck boats and ski/tow/wakeboard boats, among others. The reasons for their popularity are attractive:

- Room in the bow for extra passengers.
- Easy for boat builders to design and manufacture from existing closed bow types.
- The marketability of luxurious and comfortable lounge-type seating

The appeal of separating kids from adults. However, the dangers that come with irresponsible or inexperienced operators are significant, especially with today's high speed bow riders:

- Easy for passengers to fall overboard and be struck by the hull or the propeller.
- Forward visibility for the pilot is obstructed by occupants in the bow, heightening the risk of collisions or grounding.
- Added weight forward affects tracking, especially in waves or crossing wakes.
- Reduced freeboard forward when occupied, increases the danger of "stuffing" the bow and swamping.
- Danger of ejection and injury during collisions or sudden grounding.
- Danger of broaching in a following sea with passengers in the bow.
- Lack of PFD use and minimal, low-profile rails increases the risk of ejection and drowning.



Risk even at low speed

This type of bowrider ski boat was involved in a fatal accident when overloaded in the bow at a speed of only 10 mph when crossing its own wake.

The danger is amplified when rental bowriders are placed in the hands of inexperienced operators with large parties. Consider the conditions of a tragic death that occurred in 2014 at Lake Burton in Georgia. A 7-year-old boy lost his life while a passenger in a rented 20 ft., inboard-powered bowrider tow boat. He was one of a party of six; four of whom were children who were seated in the bow. The boat crossed its own wake at less than 10 mph. The bow stuffed under the wake, immediately swamping the boat. The boy was washed overboard; the pilot shifted the boat into reverse in an attempt to save the boat. The ejected boy became entangled and lodged in the propeller, rudder and driveshaft, where he died from drowning and massive blood loss.

Safety first

It is a common sight to see bowriders overloaded with too many occupants seated in the bow. The tragic incident shows that it does not require extreme conditions for death to result.

How can bowrider accidents be avoided? Here are some recommendations to share with skippers when the opportunity presents itself?

- Take a boating safety course.
- Read the capacity plate and never exceed weight and passenger limitations.
- Realize the legal responsibilities applying to anyone who operates a boat.
- Clear the bow area when navigating a following sea.
- Clear the bow area when operating at cruising speed or above to prevent obstructed vision.
- Require PFD use especially for bow passengers above no wake speed.
- Never overload the bow of the boat with passengers, even at what seems to be low speed.
- In the event of ejection, immediately shift to neutral and account for all passengers before maneuvering.
- Purchase a tonneau cover for the bowrider area to use when the weather gets dirty.

Co op Charting

What the heck is co op charting.? First, the name is kind of funky. Co op is an acronym that stands for cooperative or cooperation. The parties involved are volunteers from Americas Boating Club (us) and the various agencies responsible for managing aids to navigation on our waterways. Aids to navigation are frequently referred to as ATONS. ATONS are markers, buoys, signs and other devices that provide information to boaters especially safety information

Agencies are the Corps of Engineers on Lakes Hartwell, Russell and Thurmond and the Tennessee River. Coastal authorities include the Coast Guard and NOAA (National Oceanic and Atmospheric Administration). The Coast Guard repairs or supervises repair of ATONS in navigable waters and discrepancies are reported to the Coast Guard. NOAA has many functions including the production and maintenance of charts.

Volunteers like us are encouraged to regularly inspect (survey) ATONS on our lakes, rivers, and coastal waters and to promptly report discrepancies. In serious safety hazard issues, repairs often take place in a matter of days. Other, less severe problems, may not be corrected for an extended period.

Whew, after all that boiler plate what about us? Well, members of the Lake Hartwell Boating Club inspect ATONS on Lake Hartwell twice a year: February and August. Lake Hartwell is divided into eight sectors: 1 A and B, 2 A and B, 3 A and B and 4 A and B. Zone 1 A and B is near the dam. Zone 2 A and B is in and around 26 Mile Creek and the Sail club. Zone 3 A and B is built around the Seneca River and Zone 4 A and B is based on the Tugaloo.

When the inspection calendar rolls around teams are formed to perform the inspections. Sometimes whole families are involved, occasionally a solo boater goes out and often other teams are formed. For sure our experienced inspectors are eager to take passengers along, what better way to collect an audience for sea stories? When the broadcast notification email comes out, let chairman Jef Lockman know your interest and you will be included. It's a great way to learn the lake.

Two more parts to the story.

We are not limited to Lake Hartwell. We can survey and report ATON problems on any waters so if a discrepancy is discovered while cruising on the Tennessee or in Savannah waters the system will accept and recognize your reports. Once the scourge of Covid is tamed we could organize a coastal cruise and include a multi vessel survey of a section of our cruise route.

Our esteemed parent, the United States Power Squadron (AKA as Americas Boating Club) has an established program to recognize the contributions of the volunteers in Co op charting and awards are presented annually. Historically, Lake Hartwell and our immediate parent District 26, have earned national recognition for many years. Imagine. After a pleasant afternoon on the water, your name is announced across the nation in recognition of your contribution to boating safety. Pretty cool.

How to submit a report is the subject for a future issue.
