Pete Stevenson Obituary

Peter Edward Stevenson was born on May 6, 1940, in Lockport, NY. The son of the late Edward Leroy Stevenson and the late Mary Gaskill passed away on Sunday October 17, 2021. He is survived by his wife, Rosemary, son Michael Stevenson and daughters Tina Severson (Ron), Nicole Sayre (Gary) and Tara Hermans (Stephen Tilson) and nine grandchildren, Catherine (Houston), Alex, Lillian, Madelyn, Garrett, RJ, Samantha, Shelby, and Mia.

He graduated from Admiral Farragut Academy in 1958, Columbia University in 1962 and the master's program at Stern School of Business, NY University in 1976. He enlisted in the United States Marine Corps in 1961 and served in Vietnam. He remained in the USMC Reserves retiring in 1986 at the rank of Major.



He was actively involved in the textile industry from 1966 until 2015. He worked in reinforcement products in the boating and automotive applications. Returning to technical products with a main interest in soil reinforcements known as geogrids and geotextiles he is the holder of three patents on geosynthetics. He was also the founder of two geosynthetic manufacturing firms. For 27 years he worked jointly with Rosemary in the service of the International Geosynthetics Society holding positions as Secretary and Treasurer.

He was a member of the Catholic Church of St. Luke and was an active Knight of Columbus. Among his many interests he was Commander of the Lake Hartwell Sail and Power Squadron, a member of Task Force 25 of AASHTO on soil reinforcements, chair of the nonwoven industry (INDA) Geosynthetic Interest Group, a member of the Industrial Fabrics Association International (IFAI) board of directors, editor of an ASTM STP on testing and enjoyed participating in the marine survey profession as an accredited member of the Society of Accredited Marine Surveyors (SAMS).

A Day Exploring The Upper Tugaloo River 9-23-2021

Our group of six adventurers met at the headquarters of The Stephens County Foundation on the Yonah Dam road in northeastern Georgia about a fifteen minute drive from Westminster SC. Our group included three couples Pam & Charles Guderian, Nioka & Chris Rose and Janice & Don Woodard. We were welcomed by Larry who assisted us with equipment rental as well as directions on the water and transport to the launch point and schedule for meeting him for transport back to retrieve our vehicles.



We launched four kayaks and one canoe at a sandbar just below Yonah dam at about 10:30 am planning to complete our ten mile paddle by 4:00 pm at Stephen's County Park.

None of us had been on the upper part of the river above the Southern Railway trestle as this is the northern extent of the zone 4B coop charting area. The first mile or two of the river was swift due to recent rains and we encountered some shallow areas west of a large island. Past that the river moved slower and Pam spotted two river otters that were watching us approach. After paddling for several hours we were all ready to stop for lunch and to stretch our legs but a suitable spot for that was elusive due to high water conditions. Finally we located an abandoned dock on the South Carolina side and stopped for a late lunch and a much needed break.






We had been told by Larry to watch for "the second creek to the left" if we wanted to take a side trip to a remote waterfall. This "second creek" was spotted erroneously by most of us several times but eventually we stumbled upon a hidden creek which flowed into the west side of the river concealed by a swampy island. The creek was shallow, had a sandy bottom and was hidden from aerial view by a canopy of trees. In about thirty minutes we came upon Longnose Falls.
